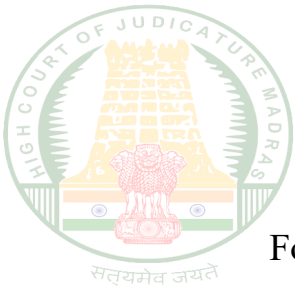

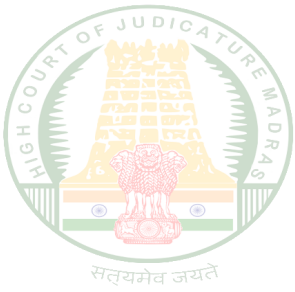
Heard the learned counsel appearing for both parties.

2. Considering the facts and circumstances of the case, the interim order granted by this Court dated 20.04.2026 is modified to the extent that the respondents are permitted to include the petitioner's College in the ongoing counselling process for student admissions.

3. It is further directed that in the event any student is allotted a seat under either the Government Quota or the Management Quota during the counselling process, the petitioner-College shall strictly charge only such fees as determined by the Fee Fixation Committee, which is extracted below.

4. The fee collection and admissions so made shall remain subject to the final outcome of this Writ Petition.

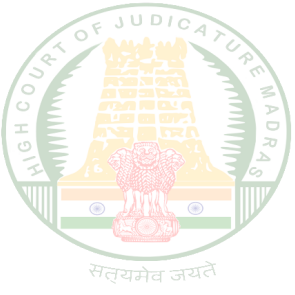
