Whereas, vide this Directorate Notice No. e. Whereas, Rijuwanur Hussain (NEET-UG-2026 Roll No. 1414105011), did not appear before the Medical Board as directed, thus his candidature get automatically cancelled for admission into MBBS course under PwD (DIVYANG) category, for the session 2026.

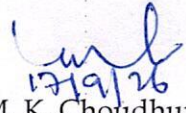

Whereas, in pursuance of the aforementioned verification report submitted by the Principal, GMC, Guwahati the status of the candidates for admission into MBBS course for the session 2026 are as follows:

Thus, the matter is dispose thereof.

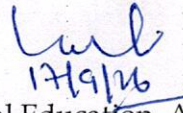
